Notes

The first player in the selection for each match has the responsibility for arranging the match. HOWEVER, if you are the second player you can contact your opponent and let them know when you are available. The aim is to play all the matches easily within the time frames set.

If a match is not played by the date given on the competition sheet or is predicted not to be able to played, initially players are asked to settle the matter themselves with players deciding who will forfeit the game or if you cannot decide YOU MUST contact Andy Mansfield to discuss. Wherever possible help will be given to complete the fixture - however if it not possible to complete and no agreement is possible, it will be Andy's decision (assisted by the committee is required) to decide who will continue into the next round based on the circumstances. There will be no appeal.

Clothing for these matches (except for the finals) is relaxed - proper footwear is mandatory, however. Attire for the Finals is club shirt (or white shirt) and whites.

Singles matches (Mixed; Mixed handicap; Mixed two wood & Ladies singles) should be played with the assistance of a marker - If you can arrange one yourself this is fine - if you need assistance, contact Andy Mansfield (andymansfield@btinternet.com 07976 237050) who will let all the players know that assistance is required - 7 days' notice of the date of the match please.

All other matches will be adjudicated by the players - the standard rules of bowls apply
